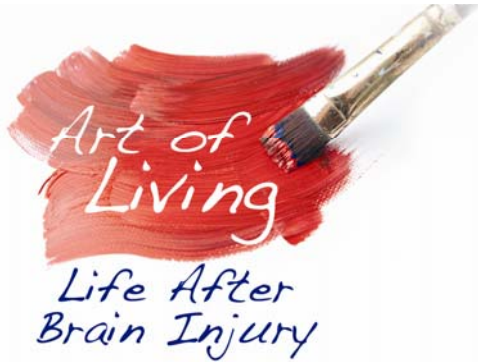


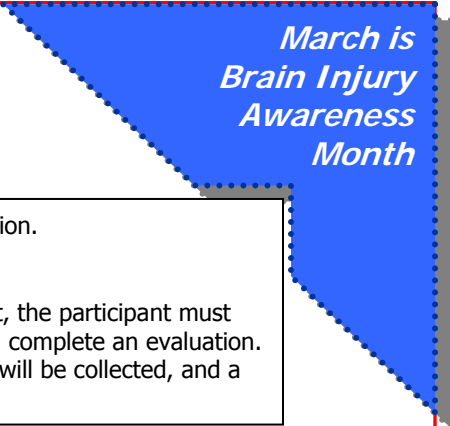

1. Discuss the challenges facing brain injured survivors and their families while working through pre-injury relationships and the changes that may be required in their new circumstances.
 2. Analyze the emotional and behavioral issues that may arise in social, educational and work settings for the person who has experienced a traumatic brain injury.
 3. Evaluate the strategies health care providers can use to assist the person in the post-brain injury phase of life to accommodate functional changes in intellectual abilities, emotional control, physical difficulties, and sexuality.
 4. Assess the availability and suitability of recreation, sport, and leisure activities and facilities for the recovering brain-injured person.
